**HIGHLIGHTS OF EASA DEVELOPMENTS AND RELATED CAA ACTIVITIES,
COVERING THE PERIOD 13 NOVEMBER – 20 DECEMBER 2010**

1 EASA Committee Meeting

- 1.1 The European Commission's EASA Committee met on 7-8 December. Most of the meeting was devoted to a review of and vote on the draft Commission Regulation laying down rules for civil aviation personnel, covering requirements related to flight crew requirements – Part FCL.
- 1.2 A number of changes were made to both the Cover Regulation and the detailed requirements in Part FCL. A significant major change to the Regulation was the addition of an opt-out for Member States allowing them not to apply its contents for two years (i.e. until April 2014) to pilots holding non-EU licences flying either foreign or EU-registered aircraft for non-commercial operations. During this time it is expected that agreements will be reached with major foreign authorities, such as the FAA, about the mutual recognition of flight crew licences. The Committee agreed to review the progress of such agreements on a regular basis.
- 1.3 The UK also secured confirmation that Flight Instructor privileges for Balloons and Sailplanes – FI (B) and FI (S) – can be obtained by holders of a Light Aircraft Pilot Licence (LAPL). More generally, UK also secured agreement that grandfathered JAR-compliant licences need not be re-issued in the EASA format until they expire, thus allowing privileges and changes to be added to existing licences.
- 1.4 There were a number of other detailed changes agreed over the two days that are too numerous to record here. Stakeholders will be notified as soon as the revised text is available.

2 EASA Management Board

- 2.1 The EASA Management Board met on 14-15 December. The first afternoon was a special session devoted to a strategic discussion of the medium-term perspective for the European Aviation Safety system. There was a substantive discussion during which a number of over-arching themes emerged, including the importance of the system itself in which various actors (Commission, Agency, National Aviation Authorities, stakeholders) all play a vital role; the need for effective partnership working between those actors; the

prioritisation of safety issues; and the evolution of the regulatory approach to risk-based, outcome-focused safety management.

- 2.2 On the second day, the Board discussed first drafts of a European Aviation Safety Programme and a European Aviation Safety Plan, welcoming the work so far on these important documents. The Agency's Business Plan for 2011-2015 and the 2011 Budget were adopted.

3 NAA/EASA Partnership meeting

- 3.1 The EASA/NAA partnership forum met on 25 November, attended by the CAA's Group Director Safety Regulation. There was a presentation on the European Aviation Safety Plan which was welcomed as a good first step in the planning process, pointing the way towards further safety actions to be developed collaboratively between the Agency, NAAs and industry.
- 3.2 There were also discussions on risk-based safety regulation and oversight, ICAO article 83bis, N-Registered aircraft flown by pilots holding FAA licences, and safety promotion actions with regards to General Aviation.

CRD to NPA 2008-15	Essential Requirements for Civil Aviation Environmental Protection
